____ Car should be returned clean (no garbage, spills, food leftovers, stains or other interior damages). If returned dirty - \$70 fee will be charged for cleaning.

____ Customer held responsible for all lost car keys and/or a lockout situation. One week rental minimum. NO refunds for early returns.

____ Vehicle should be returned on the day specified in your contract. In case of extending, a 24-hour notice is required. Failure will lead to \$50 penalty.

____ You will be held responsible for any parking tickets attributed to the rented Vehicle during the rental period. We encourage you to pay parking tickets directly to avoid an administrative fee. If we must process parking tickets through our office, you will be charged the actual amount paid for the traffic infraction plus an administrative fee of not more than our out of pocket expenses plus up to four hours of work multiplied by Hawaii's current minimum wage pursuant to HRS S 437D-17.5 (up to \$37 in 2017, and \$40.40 beginning January 1, 2018).

Only the person(s) that are listed on this Car Rental Agreement and above the age of twenty-one may drive this vehicle. The above mentioned Car Renter is hereby responsible for all collision damage to the vehicle regardless if someone else is at fault or the cause is not known. The Car Renter is fully responsible for the cost of any repair up to the value of the vehicle. The Car Renter's Insurance may cover all or only part of the financial liability for the rented vehicle. Car Renter should check with their insurance company regarding their coverage and what they are and are not liable for. If there is no breach of this contract the Car Renter and any authorized driver is provided liability insurance and is limited to the minimum financial responsibility as required by state law. Liability Insurance will only be in excess over any and all additional collectible insurance. The above mentioned Car Renter hereby waives all uninsured and under insured motorists, no fault and any other optional additional coverage. If such additional coverage cannot be waived or excluded then the Car Renter agrees that such coverage will be limited to only the minimum state requirements.

The Car Renter is hereby bound by the terms and conditions of this Car Rental Agreement. The vehicle must be returned on or before the above indicated due back date and time. There will be additional fees due if the vehicle is not returned as specified above. Where it is permitted by law the Car Renter hereby authorizes us to process their credit card information in their name for all Car Rental charges, including the full vehicle value of any vehicle that is not returned to the Car Rental Company, all fines, towing, any court costs, penalties, and or administrative fees that we may incur for parking, traffic and or other violations that may be incurred by the Car Renter during the Car Rental term period as stated above and to apply any payments made to the charges in whatever order that the Car Rental Company sees as necessary. By signing below Car Renter is also signing their Car Rental credit card voucher.

Prohibited uses of the vehicle. Vehicle will not be used or operated by anyone:

- Who is under 21 years of age.
- Who is not listed as an additional driver on this rental agreement.
- To carry persons or property for hire.
- In any race, test or similar type contest or activity.
- In a careless or negligent manner.
- Under the influence of alcohol or narcotics.
- For any illegal purpose or in the commission of a crime.
- If vehicle is obtained from lessor by fraud or misrepresentation.
- Other than on paved roads or graded private road or driveway.
- Who loads vehicle beyond its rated capacity.
- Who allows more passengers than the vehicle has seat belts for, or is designated to carry.

PROHIBITED USE OF THE VEHICLE VIOLATES THIS AGREEMENT, VOIDS ALL LIABILITY AND ORHER INSURANCE COVERAGE (WHERE PERMITTED BY LAW), MAKES LESSEE RESPONSIBLE FOR ALL LOSS OR DAMAGE TO OR CONNECTED WITH THE VEHICLE, REGARDLESS OR CAUSE, INCLUDING BUT NOT LIMITED TO LESSOR'S EXPENSES, INCLUDING LOSS OF USE.

INSURANCE: Customer agrees to maintain automobile insurance during the term of this rental agreement, providing the owner, the renter, and any other person, using or operating the rental vehicle with the following primary coverage: a. Bodily injury and property damage liability coverage; b. Personal injury protection, no-fault, or similar coverage where required; c. Uninsured / underinsured coverage where required; d. Comprehensive and collision n damage coverage extending to the rental vehicle. Customer's insurance will provide at least the minimum limits of coverage required by the financial responsibility laws of the state where the loss occurs. Because the customer is providing automobile insurance, we are not. In states where the law requires us to provide insurance, we will provide excess insurance only, up to the minimum limits required by the financial responsibility laws, the customer's insurance will be primary. Any insurance we are required to provide applies to claims of bodily limitations applicable to anyone claiming coverage. Customer agrees to cooperate with our insurer if any claim is made. Our insurance applies only in the United States, and Canada. Where permitted by law, customer rejects uninsured, underinsured, supplemental, personal injury protection, and no-fault coverage. Where we are required to provide such coverage, renter i afforded the minimum limits, required by law. Any breach of this agreement will void any insurance coverage.
